

Minutes of the Upwood Parish Council held in the National Schools on **Thursday the 16th February 1933.**

Minutes

Rating Authority.

A letter was read from the clerk to the Rural District Council asking this Council to appoint two members to act as members of the Rating Committee. Resolved that Messrs. A. H. Ingle and J. H. Key be appointed to serve on the Rating Committee of the District Council.

Constables.

Resolved, that after careful consideration of the question of uniting Great Raveley, Little Raveley, and Upwood to form one administrative Parish under one Parish Council, this meeting of the Parish Council are of opinion that it is desirable that Little Raveley and Great Raveley should be united with Upwood provided guarantees can be given that representatives could be obtained from the Parishes concerned to sit upon any authority that may be set up.
